Commons Act 2006 - Section 19 2(a) NOTICE OF APPLICATION TO CORRECT THE REGISTER

Notice is hereby given that an application has been made by **Christopher Carss** ("the Applicant") to Cumbria County Council as Commons Registration Authority, under Section 19 (2) paragraph (a) of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to common land register unit CL78 Grasmere Common.

A summary of the effect of the application is as follows: CL78 Grasmere Common was provisionally registered on 29th May 1968 under section 4 of the Commons Registration Act 1965, pursuant to an application made by The National Trust on 18th April 1968 and numbered 220 ("the 1968 Application"). The provisional registration of the 1968 Application became final on 6th April 1972. The Applicant claims that the registration authority made a mistake in not registering what it was asked to register. The applicant believes that the area shown outlined in red on the attached plan ("the Application Land") was not included as part of original application number 220 and therefore the authority should not have registered it as part of CL78. It appears that the land was not shown as part of the common on the provisional registration map, and therefore it appears as though it was included in error when the current, definitive map was produced. The Applicant seeks by this application to remove the Application Land from register unit CL78 Grasmere Common.

If the application is granted, in whole or in part, the registration authority will give effect to the determination by deregistering the Application Land, which will entail the addition of a registration amendment entry in register CL78 Grasmere Common confirming deregistration of part, and the amendment or preparation of a fresh edition of the register map showing only the remaining land contained in unit number CL78 as registered common land and the Application Land marked as deregistered.

Any person wishing to make representations:

- must state the name and postal address of the person making them, and the nature of that person's
 interest (if any) in any land affected by the application and may include an e-mail address;
- must be signed by the person making them;
- must state the grounds on which they are made; and

Representations will not be treated as confidential, to determine the application it will be necessary for the Commons Registration Authority to disclose information received to others, which will include the Applicants and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The period for making representations expires at 5pm on 8th February 2021
