## Commons Act 2006 – Schedule 3 NOTICE OF APPLICATION TO AMEND THE REGISTER TO RECORD AN HISTORIC EVENT Primary Application - Severance

Notice is hereby given that an application has been made by **John Mitchell Angus** and **Eve Gabrielle Napoletani** ("the Applicants") to Cumbria County Council as Commons Registration Authority, under Schedule 3 of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to common land register unit CL69, Birker Fell.

A summary of the effect of the application is as follows: The right to graze 1200 sheep, plus lambs under 9 months old, 26 hill cows plus calves under one year old, 12 heifers to include all female over one year old, until calving their first calf on Birker Fell, comprising the whole of the land in the register unit ("the Right") is registered as attached to land described as "High Birkerthwaite and Birkerthwaite" at entry 8 of register unit CL69.

55.999 acres of the original 104.437 acre dominant tenement (the dominant tenement being the land described more accurately in the original application) was transferred by way of a Deed of Partition along with the entirety of the Right on 5<sup>th</sup> February 1982 ("the 1982 Deed"). On the 26<sup>th</sup> June 1990 the entirety of the Right was then once again transferred, but with only 38.3 acres of the 55.999 acres previously transferred ("the 1990 Conveyance").

The Applicants have provided copies of both the 1982 Deed and the 1990 Conveyance. The Applicants claim that the effect of these transfers was to sever the portion of the Right that was attached to the land that was not transferred with the Right. The Applicants seek by this application to register the severance in the register.

If this application is granted, the portion of the Right originally attached to the 66.137 acres of land not included in the 1990 Conveyance will be considered to be severed from the land and held in gross in the name of the listed purchaser.

Any person wishing to make representations:

- must state the grounds on which they are made; and

Any representations made will not be treated as confidential, to determine the application it will be necessary for the commons registration authority to disclose information received to others, which will include the Applicant and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may also be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The period for making representations expires at 5pm on 22<sup>nd</sup> June 2022.
