Commons Act 2006 – Section 11 NOTICE OF APPLICATION TO AMEND THE REGISTER TO RE-ALLOCATE AN ATTACHED RIGHT OF COMMON

Primary Application - Re-allocation

Notice is hereby given that an application has been made by **Gillian Elaine Stuart** ("the Applicant") to Cumbria County Council as Commons Registration Authority, under Section 11 of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to common land register CL123 St. John's Common.

A summary of the effect of the application is as follows: The right to graze 248 ewes and followers or 50 cattle or 25 horses or mixed equivalents and the right of cutting and harvesting bracken on St. John's Common comprising the whole of the land in this register unit ("the Right") is registered as attached to 52.555 acres of land at Bram Cragg Farm, comprising O.S. plots numbered 813, 810, 817, 818, 819, 825, 820, 822, 821, 824, 826, 823, 849, 848, 850, 851, 852, 861 and 887 ("the Dominant Tenement") at entry 46 of register unit CL123.

Part of the O.S. field 861 amounting to 0.187 acres and shown edged red on the accompanying plan is to be dedicated as public highway as part of a Highways Road Scheme. The Applicant seeks by this application to reallocate the portion of the Right attached to the aforementioned part of O.S. 861 so that the whole of the Right is recorded in the register as attaching to the rest of the Dominant Tenement as shown edged blue on the plan.

If this application is granted, the registration authority will give effect to the determination by registering a re-allocation of the Right which will entail the strikethrough of the current entry 46 in the Rights Section of register unit CL123, the addition of a register amendment entry to show the whole of the Right attached to O.S. plots numbered 813, 810, 817, 818, 819, 825, 820, 822, 821, 824, 826, 823, 849, 848, 850, 851, 852, part 861 and 887 and the addition of a supplemental map showing the new dominant tenement.

Any person wishing to make representations:

- must guote the Application No. CA5/1
- must state the name and postal address of the person making them, and the nature of that person's interest (if any) in any land affected by the application and may include an e-mail address;
- must be signed by the person making them;
- must state the grounds on which they are made; and

Representations may also be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.
