**DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER (NO 5) 2024**

The Order is made by Cumberland Council ("the Authority") pursuant to Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to the Surveying Authority that the definitive map and statement for Cumberland require modification in consequence of the occurrence of an event specified in Section 53(3)(c)(i), namely, the discovery of evidence which (when considered with all other relevant evidence available to the surveying authority) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path, a restricted byway or, subject to section 54A, a byway open to all traffic.

The authority has consulted with every local authority whose area includes the land to which the Order relates.

The Authority hereby order that:

1. For the purposes of this Order the relevant date shall be 1 October 2024.
2. The definitive map and statement for the Cumberland shall be modified as described in the Schedule and shown on the map attached to the order.
3. This Order shall have effect on the date it is confirmed and may be cited as the Cumberland Council (Parish of Stanwix Rural: District of Carlisle) Definitive Map and Statement Modification Order (No 5) 2024.

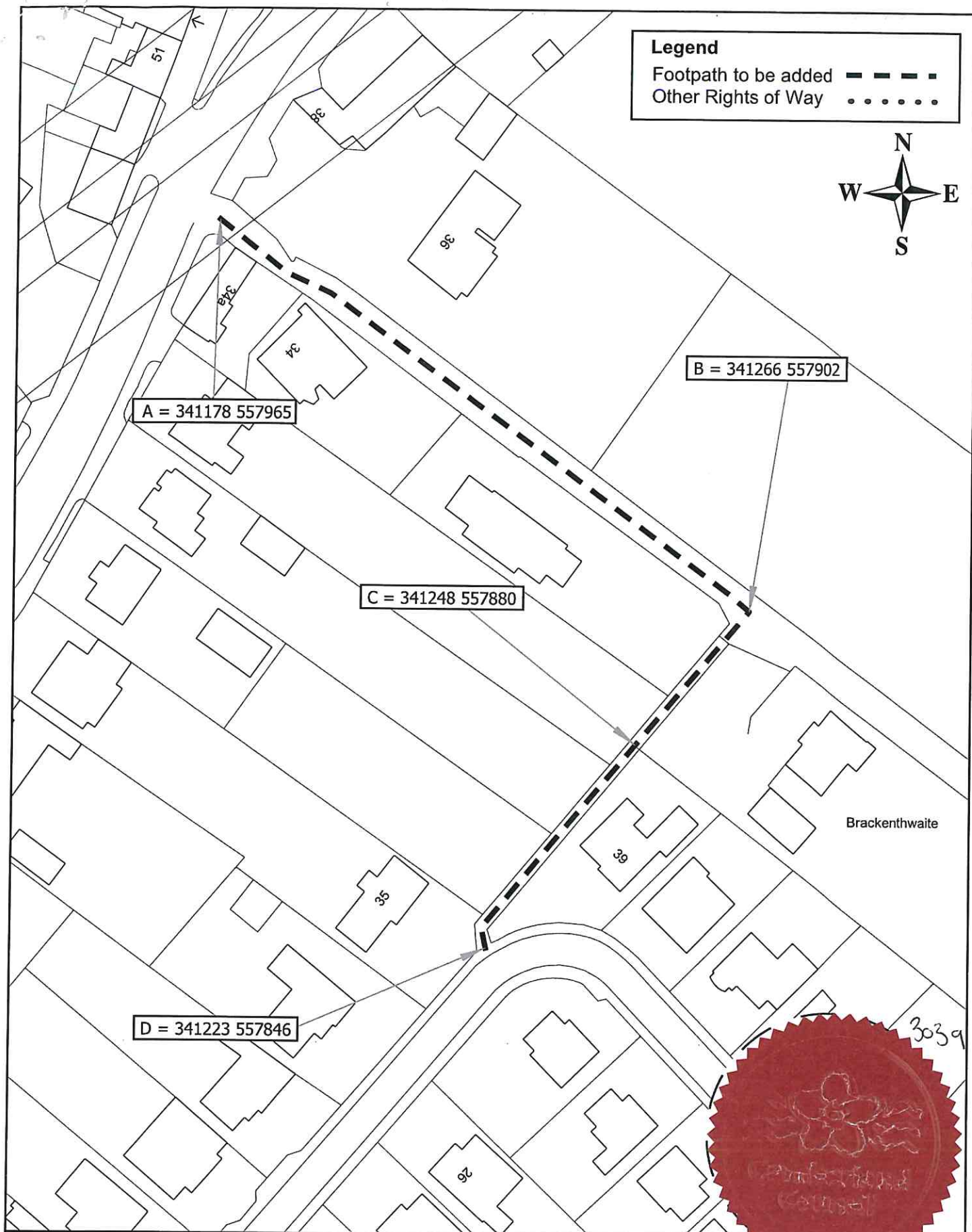
