**STATUTORY CONSULTATION: PROPOSED CHANGES TO THE CARLISLE TRAFFIC REGULATION ORDER – CARLISLE STATION GATEWAY**

I am writing to you as part of a Statutory Consultation process, to inform you that Cumberland Council is proposing to make changes to the Carlisle Traffic Regulation Order relating to the locations on the attached plans.

The proposals are all being considered as part of the Carlisle Station Gateway Project. The planned improvements support regional economic growth, encourage rail travel, and contribute to broader environmental and decarbonisation goals by aiming to reduce reliance on vehicular traffic, whilst simultaneously boosting Carlisle's footfall and profile on the national rail map, facilitating improved access and connectivity, not only to Carlisle but also to the wider Borderlands region.

Plans CSG-WSP-LSI-102-DR-CH-1001 and CSG-WSP-LSI-102-DR-CH-2001, which detail several proposed changes, are enclosed. These should be considered in conjunction with one another and the related Legal Notice. Plan CSG-WSP-LSI-102-DR-CH-4001 and a Legal Notice are also enclosed in relation to the proposed installation of three raised tables. If you wish to comment or make representations in relation to this proposal, you should reply in writing to the above address or by emailing [TROresponses@cumberland.gov.uk](mailto:TROresponses@cumberland.gov.uk) not later than 21 March 2025, clearly marking your correspondence with the reference "CASG-TAB-2025".

**Plan CSG-WSP-LSI-102-DR-CH-5001 and a Legal Notice are also enclosed in relation to the council's intention to widen some existing sections of footway and convert parts to segregated cycle tracks. If you wish to comment upon these plans you should reply in writing to the above address or by emailing [kim.baxter@cumbria.gov.uk](mailto:kim.baxter@cumbria.gov.uk) not later than 21 March 2025, clearly marking your correspondence with the reference "CASG-Footway conversion".**

For information, also enclosed is an additional plan CSG-WSP-LSI-102-DR-CH-3001 and a Legal Notice detailing the council's intention to install a number of controlled crossings.
