## **Long-Term Empty Premium Exception application**

Since 2013, Councils in England have been able to charge a premium for long-term empty properties. For the purpose of council tax, long-term empty homes are dwellings which have been unoccupied and substantially unfurnished for a period.

The Government recognises that there may be instances where it may be inappropriate for the council tax premium to apply. On 1<sup>st</sup> November 2024 the Government legislated exceptions to the long-term empty premium, commencing from 1<sup>st</sup> April 2025.
