


DEPOSIT OF STATEMENT & PLAN

STATUTORY DECLARATION



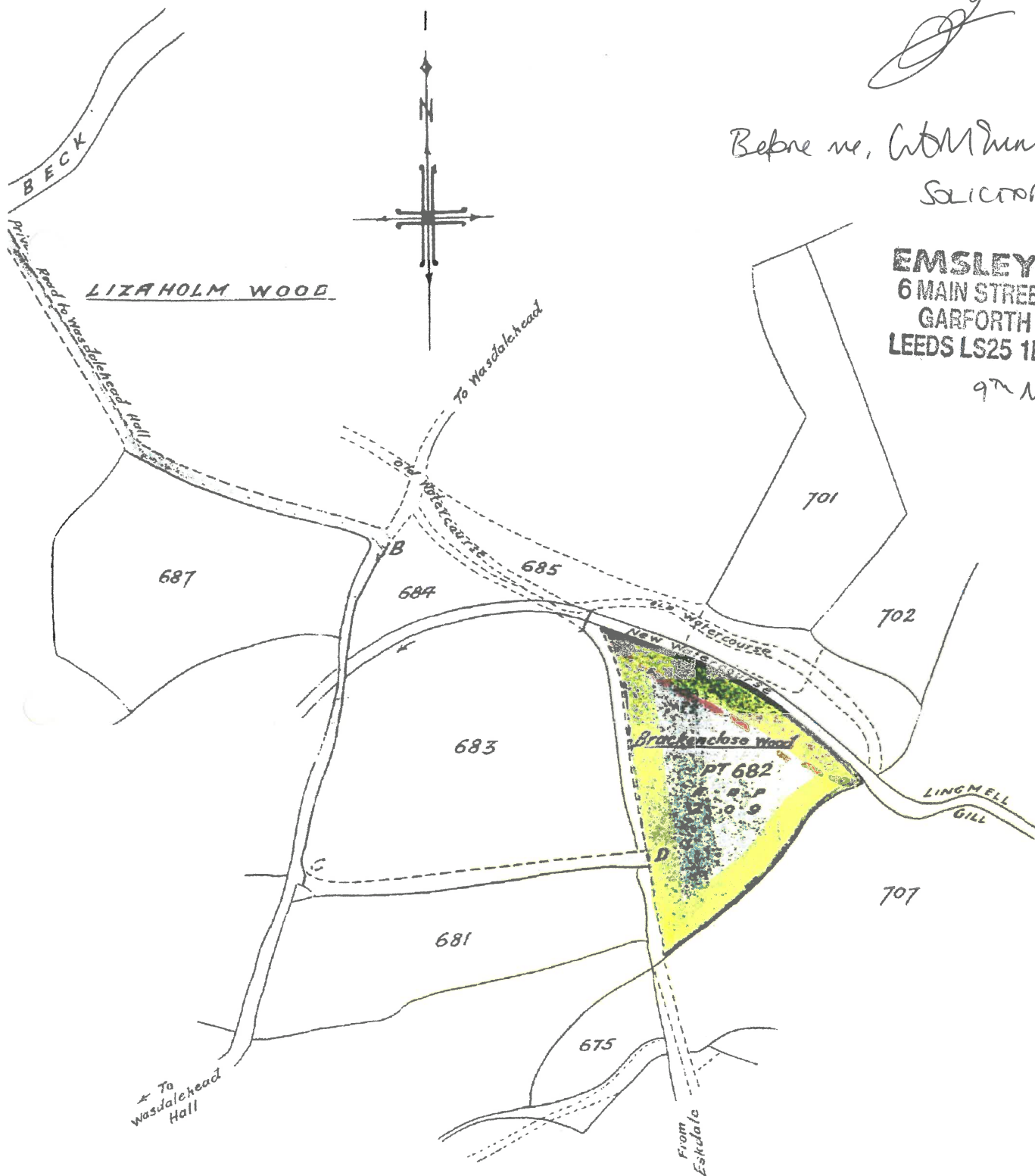

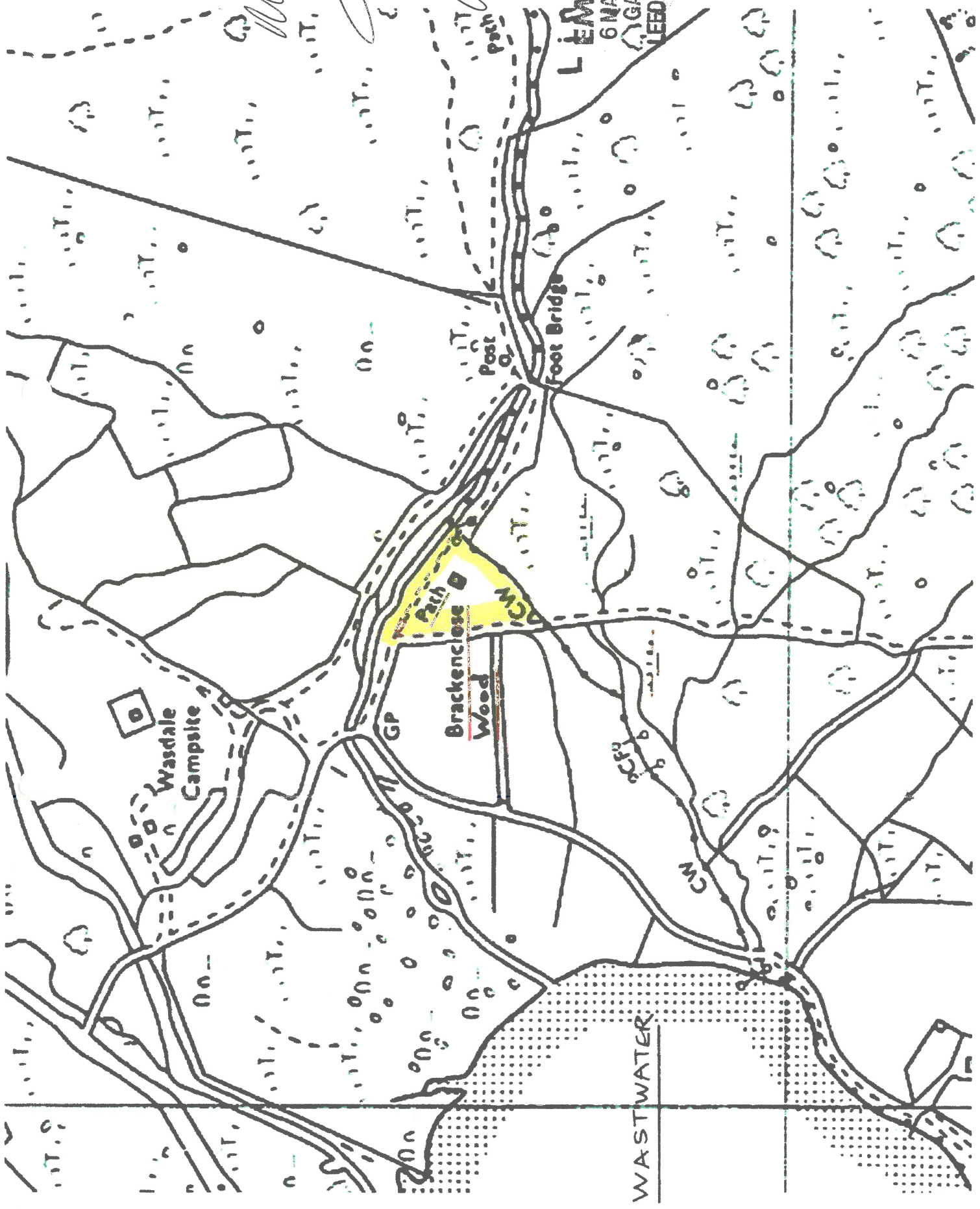
