

CUMBERLAND COUNCIL

(VARIOUS ROADS, KESWICK AND SURROUNDING AREA) (CONSOLIDATION AND PROVISION OF TRAFFIC REGULATIONS) ORDER 2023

1. Cumberland Council hereby give notice that it proposes to make the above Order under Sections 1, 2, 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53, 64 and 84 of the Road Traffic Regulation Act 1984.
2. The effect of the Order will be to consolidate, revoke and re-enact the provisions of the Cumberland Council (Various Roads, Keswick and Surrounding Area) (Consolidation and Provision of Traffic Regulations) Order 2023, and introduce following proposed restrictions, into one concise Order.
3. The proposals are as follows: -
 - (1) To introduce "No Waiting At Any Time" restrictions on parts of the following roads: -
 - (i) Acorn Street, Blencathra Street, Blackrigg Drive, Church Street, Cross Street, Eskin Street, George Street, Greta Street, Helvellyn Street, Leonard Street, Meyers Street, Ratcliffe Place, Shorley Lane, Skiddaw Street, Southey Street, St Herbert Street, Wordsworth Street, Keswick;
 - (ii) C2057 Portinscale;
 - (iii) B5322 St Johns in the Vale; and
 - (iv) B5292 Braithwaite.
 - (2) To extend the "No Waiting At Any Time" restrictions on parts of the following roads: -
 - (i) Southey Street, Keswick;
 - (ii) the C2057 and the U2219 in Portinscale
