## CUMBERLAND COUNCIL (VARIOUS ROADS, COCKERMOUTH AND SURROUNDING AREA) (CONSOLIDATION AND PROVISION OF TRAFFIC REGULATIONS) ORDER 2025

- 1. Cumberland Council hereby give notice that on 1 July 2025 it made the above Order under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 of the Road Traffic Regulation Act 1984.
- 2. The Order will come into operation on 18 July 2025 and its effect will be to consolidate the provisions of The County of Cumbria (Various Roads, Cockermouth and Surrounding Area) (Consolidation and Provision of Traffic Regulations) Order 2023; and the following amendments/restrictions, into one concise Order: -
  - (a) Removal of the "Disc Parking, Waiting Limited to 2 hours, Return Prohibited within 2 Hours, 8.00 am – 6.00 pm, Monday – Saturday, Residents NOT exempt" restriction on the west side of Isel Road, Cockermouth;
  - (b) Introduce "No Waiting At Any Time" (double yellow line) restrictions, on the following lengths of road: B5291 Bassenthwaite Lake (north);
    B5289 Buttermere Lake;
    Bridge Street Close, Cockermouth; Moor Road (south west side), Great Broughton (see (d) below);
    Moor Road (north east side), and Moorfield Bank, Great Broughton; and B5289 Honister Pass.
  - (c) Removal of "No Waiting At Any Time" (double yellow line) restrictions, on the northeast side of B5289 Buttermere (Opposite Bridge Hotel); and
  - (d) Replacing the "No Waiting, 8.00 am 9.30 am and 2.30 pm 4.00 pm, Monday Friday" restriction on Moor Road, Great Broughton with "No Waiting At Any Time" (double yellow line) restriction.

4. If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the grounds that any requirement of that Act or any instrument made there under has not been complied with in relation to the Order, you may within six weeks of 1 July 2025 apply to the High Court for this purpose.
