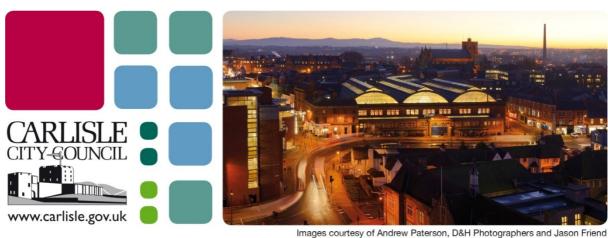

I believe that the housing policy HO1 and site R15 (Hill Head, Scotby) are unjustification
My reasons are:
The number of houses thought to be required is far too high & is much higher than
the average number of houses built in the past 15-20 years. Therefore this site does
not need to be included.
Obviously developing this site will have an impact on the attractive landscape of th
village from the A69.

This 'greenfield site' is currently used for agriculture and contributes to our rural economy and food production.

There is a potential drainage problem on this site and known flooding problems on Scotby road.

Developing this site will have a huge impact on the amenities of the properties closeby.

Many of the residents on Hill Head are retired and would be disturbed by all the noise from the building work and extra traffic.

The houses on Hill Head are almost all bungalows and those on the side of the proposed development will completely lose their view and will be well and truly overlooked. This will also no doubt effect house prices.

The road on Hill head is already narrow and there are only 25 houses, to increase the number using this road by over double will lead to a very busy road. There are children and teenagers living on Scotby Road and Hill Head.

Scotby road is a very busy road and is regularly used as a 'rat run' for people avoiding Junction 43.

The junction onto the A69 from Scotby Road is very busy and there are regularly 'near misses' due to this and the large Nursery across the road.

Scotby School is already oversubscribed and there is a new development on the other side of the village, which had led to a noticable increase in traffic through the village.

The Council should be looking at redeveloping on land which is underused or derilict and reinvesting in older housing areas in Carlisle.
