I believe that the Housing Policy H01 and the inclusion of site R15 (Hill Head Scotby)				
is not justified, resulting in the local plan being unsound. My reasons are as follows:				
The Carlisle and District forecast of 565 houses being built per year is unrealistically				
high and exceeds by 54% the average of 367 houses per year built over the last 20				
years. The inclusion of this site is not required in order to meet the housing needs of				
Carlisle.				

The site abuts the Northern edge of Scotby village and such its development would adversely affect the attractive landscape and setting of the village from the A69. The site extends into open countryside, resulting in any development being seen as an unwarranted and unnecessary intrusion into the landscape. The local plan is supposed to remove sites in open countryside in the initial sift and indeed the Hill Head Plan was rejected in spring 2014.

The greenfield site consists of high quality Grade 2 agricultural land, the highest quality in Cumbria, which is actively farmed and makes a useful contribution to food security and the rural economy.

The site was rejected in the Local Plan consultation last spring, resulting in many residents being unaware of this latest proposal.

The development of this site would have an adverse impact on the amenities of the properties along Hill Head and Scotby Road and on the enjoyment of their homes and quality of life. The inclusion of land behind Holme Close was rejected on amenity grounds and for consistency, so should the Hill Head site

Hill Head is already restrictive for traffic when residents park outside their homes and when wider vehicles use the road. The road is simply too narrow to support the increase in traffic a new development would bring.

The proposed access to the site, (the lane from Hill Head) was not built to take the volume of traffic the new development would bring and is not wide enough to take a road for two way traffic and pavements. The two houses adjacent to this lane were built with the only vehicular access being from this lane. If this lane were to be turned into an access road, getting in and out of these properties would not be safe as it would mean turning out of the driveway on a blind corner. The development would also have an extremely adverse effect on these residents' enjoyment of their homes and quality of life. The Plan states 'the proposed access will require upgrading to be wide enough for two way traffic and pedestrian footways'. As the proposed access is bordered by residents' gardens, there is no room to widen it, therefore it can only remain too narrow.

There is a potential drainage problem on this site, as identified by United Utililities and the Environment agencies. There are known flooding problems along Scotby road due to the lack of capacity in the foul/surface water sewers. In addition, the main drain in Hill Head has previously backed up due to the narrowness of the sewer pipe.

Development of the site would undermine the council's policy of trying to encourage urban regeneration in Carlisle, in particular in bringing forward underused and derelict sites and encouraging re-investment in the older housing neighbourhoods.
Previous surveys in Hill Head have found evidence of subsidence in the area. The building development could surely exacerbate this problem and affect the current housing in Hill Head.
A significant number of houses has already been built within the village of Scotby with more planned. The roads around the village are already conjested and those around the school, which will presumably need to expand further, should more housing be built, are virtually unusable at certain times of the day. They are simply too narrow to cope with the increased volume of traffic.
