## NOTICE OF APPLICATION TO AMEND THE REGISTER TO RECORD AN HISTORIC EVENT – SEVERANCE

Notice is hereby given that an application has been made by **William Ridley**, **as personal representative of Malcolm Ridley** ("the Applicant") to Cumberland Council as Commons Registration Authority, under Schedule 3 of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to common land register unit CL20, Caldbeck Common.

The right to graze 35 units on Caldbeck Fell, comprising the whole of the land in the register unit ("the Right"), is recorded at entry 477 of register unit CL20 as being attached to O.S. No. pt462 ("the Dominant Tenement").

The 35 grazing rights recorded at entry 477 derived from entry 35 which registered 145 grazing rights in total. The Applicant claims that all 145 rights were transferred between two conveyances dated 21<sup>st</sup> October 1985 (10 rights) and 12<sup>th</sup> October 1987 (135 rights), neither of which included any of the Dominant Tenement at entry 477. The Applicant therefore claims that by 12<sup>th</sup> October 1987 the Right had been severed, given that the Right had been transferred, but not the Dominant Tenement. The Dominant Tenement was then transferred on 16<sup>th</sup> October 1987 in a conveyance which expressly excluded any grazing rights on Caldbeck Common.

The Applicant also highlights that the land conveyed on 12<sup>th</sup> October 1987 was all subsequently conveyed by Malcolm Ridley in 2001 along with 100 grazing rights, with Malcolm Ridley retaining the balance of 35 grazing rights that he acquired in 1987. The Applicant claims that he retained these rights in gross, given that they were severed in October 1987.

By way of evidence the Applicant has provided copies of both 1987 conveyances referred to, along with a Rider detailing the claimed severance.

The Applicant seeks by this application to register the severance of the Right in the register.

If this application is granted, the registration authority will give effect to the determination by cancelling CL20, entry 477 and creating a new entry showing the Right as having been severed and held in gross in the name of the transferee to the 12<sup>th</sup> October 1987 conveyance, Mr Malcolm Ridley.
