

**CUMBERLAND COUNCIL**  
**ALLERDALE BOROUGH COUNCIL (OFF STREET PARKING PLACES) ORDER 2018**  
**(VARIATION NO 2) (WORKINGTON) ORDER 20><**

1. NOTICE is hereby given that Cumberland Council (“the Council”) proposes to make the above Order under Sections 32, 33, 34, 35, 35A, 35C and 39 of the Road Traffic Regulation Act 1984.
2. The effect of the proposed Order will be to add the entry specified in the Schedule below into Schedule 1 of the Order.

NB: The operation of the car park will change from a barrier, “pay on exit” system to a “pay and display” system.
