

## Commons Act 2006 – Schedule 3

### NOTICE OF APPLICATION TO AMEND THE REGISTER TO RECORD AN HISTORIC EVENT – APPORTIONMENT

Notice is hereby given that an application has been made **Andrew Robert Thornton** ("the Applicant") to Cumberland Council as Commons Registration Authority, under Schedule 3 of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014.

The application relates to common land register unit CL73, Waberthwaite Fell.

The right to graze 400 sheep plus followers, or 250 sheep and 15 cattle plus followers on Waberthwaite Fell, comprising the whole of the land in register unit CL73, is recorded at entry 5 of register unit CL73 ("the Right").

The Right is recorded as being attached to land at Grange Farm, Waberthwaite, comprising of O.S. field Nos. 188, 189, 190, 191, 192, 193, 194, 195, 196, 197, 198, 199, 200, 201, 202, 203, 204, 205, 206, 207, 210, 320, 321, 322 and 318 ("the Dominant Tenement").

The Applicant claims that severance of part of the Right occurred on 3 March 1992, when a conveyance transferred the entirety of the Right to James Charleton Thornton and Robert Charleton Thornton ("the Purchasers"), but with only part of the Dominant Tenement. The part of the Dominant Tenement not conveyed with the Right comprised of O.S. Nos. pt196, pt200, 201, pt202, pt203, pt321, 322 and 318 ("the Retained Land").

The Applicant seeks by this application to show that the portion of the Right associated with the Retained Land amounts to 52.20 sheep rights (or 32.63 sheep rights and 1.96 cattle rights).

This secondary application can only be considered if the primary application (CA14/94) is granted. If granted, the registration authority will give effect to the determination by cancelling entry 5 and creating two new entries, one showing the Purchasers as the owner in gross of the part of the Right once attached to the Retained Land (52.20 sheep rights, or 32.63 sheep rights and 1.96 cattle rights), and the other showing the remaining portion of the Right attached to the part of the Dominant Tenement that was transferred with the Right (347.80 sheep rights, or 217.37 sheep rights and 13.04 cattle rights).

Any person wishing to make representations:

- must quote the Application No. **CA14/95**,
- must state the name and postal address of the person making them, and the nature of that person's interest (if any) in any land affected by the application and may include an e-mail address;
- must be signed by the person making them;
- must state the grounds on which they are made; and

Any representations made will not be treated as confidential, to determine the application it will be necessary for the commons registration authority to disclose information received to others, which will include the Applicant and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act


