### Application for the apportionment of a right of common

#### NOTICE OF DETERMINATION

Application Number: CA3/57

Notice is hereby given that Westmorland and Furness Council, as the Commons Registration Authority (“the CRA”), has considered an application submitted by **Joseph Henry Robinson and John Stafford Cartmel** (“the Applicants”) seeking to apportion the right of common recorded at entry 19 of commons register unit CL66 Saddleback near Threlkeld Common (“the right”), and to register the apportionment in the register.

#### Decision


The CRA resolved to accept the application to amend the registers by registering the apportionment of the Right.

#### Reasons

The Commons Registration Officer assessed the application and found it to be duly made under the criteria prescribed by the relevant regulations and guidance. No objections were received against the application.

#### Outcome

The rights section of the register for CL66 Saddleback near Threlkeld common has been amended to show the Right as apportioned in accordance with the Notice of Application attached to this decision.

### NOTICE OF APPLICATION FOR THE APPORTIONMENT OF A RIGHT OF COMMON

Notice is hereby given that an application has been made by **Joseph Henry Robinson and John Stafford Cartmel** ("the Applicants") to Westmorland and Furness Council, as Commons Registration Authority, under Section 8 of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014. The application relates to entry number 19 of common land register unit CL66 Saddleback near Threlkeld Common.

A summary of the effect of the application is as follows:

The right to graze 250 ewes and followers and 70 hoggs, on Saddleback Common, comprising the whole of the land in the register unit, is recorded as attached to land at Blease, Threlkeld O.S. Nos. 347, 348, 349, 345, 344, 343, 350, 342, 337, 386, 341 and 339 ("the Right").

Pursuant to the division of the land to which the Right is attached, the Applicants seek by this application to register apportionment of the Right appropriate to the part of land transferred and now in their ownership.

If the application is granted, in whole or in part, the registration authority will give effect to the determination by making the following amendment to the commons register:

1. Entry number 19 will be deleted and reference made to the new corresponding entries.
2. Addition of supplemental maps.
3. The following entries will be made to the rights section of the commons register to show the proportionate apportionment of the Right to (a) the Applicants and (b) the remainder of the Right:
  - a. The right to graze 124.48 ewes and followers and 34.86 hoggs, on Saddleback Common, comprising the whole of the land in the register unit, is recorded as attached to land at Blease, Threlkeld O.S. Nos. 347, 348, 349, 345, 344 and 343 as shown coloured orange on the proposed supplemental map.
  - b. The right to graze 125.52 ewes and followers and 34.14 hoggs, on Saddleback Common, comprising the whole of the land in the register unit, is recorded as attached to land at Blease, Threlkeld O.S. Nos. 350, 342, 337, 386, 341 and 339 as shown coloured green on the proposed supplemental map.

Any person wishing to make representations:

- must quote the Application No. **CA3/57**
- must state the name and postal address of the person making them, and the nature of that person's interest (if any) in any land affected by the application and may include an e-mail address;
- must be signed by the person making them;
- must state the grounds on which they are made; and




Any representations made will not be treated as confidential, to determine the application it will be necessary for the commons registration authority to disclose information received to others, which will include the Applicants and may include other local authorities, Government Departments, public bodies, other organisations and members of the public (Data Protection Act 1998). Representations may also be disclosed upon receipt of a request for information under the Environmental Information Regulations 2004 or the Freedom of information Act 2000.

The period for making representations expires at 5pm on **08 January 2026**.
